2) Advance drawl Rs. 406.11 lakhs (Rupees Four Crore Six Lakhs & Eleven Thousands) only as detailed above, by Director Ayush, J&K for e-transfer of funds into the Single Nodal Account of NAM Scheme (J&K AYUSH Society) for utilization of funds during the current financial year 2023-24.
