Advance drawl of Rs. 700.00 lakhs (Rupees Seven Crore) only as detailed above, by Director Finance, Health & Medical Education Department for crediting the funds into the Single Nodal Account (SNA) of the Scheme so that funds be transferred to SKIMS, Srinagar for its utilization on the approved components of scheme during the current financial year 2023-24.

The release/advance drawl of funds shall be, however, subject to the following conditions:-

1. The expenditure shall be made strictly as according to the classification under which funds have been authorized by the Finance Department.
2. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
3. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
4. Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance

5. The concerned HOD shall send status report about the scheme in terms of physical and financial progress made during the current financial year.
6. The concerned HOD shall send the Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2024 to Govt. of India under intimation to this department.
7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
8. Director Finance, H&ME Department shall vouchsafe the availability of funds on the BEAMS portal as accordingly release/ transfer the same to the concerned HOD.
9. The expenditure shall be incurred strictly as per the guidelines of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of India.
10. The Red Accounts of advance drawl be furnished to the concerned quarters within the stipulated time.
11. All conditions as stipulated in BEAMS generated release order shall be adhered to in letter & spirit.
