Subject: Settlement of intervening period of absence in favour of Dr. Dimpy Raina, Dental Surgeon, District Hospital Udhampur.

WHEREAS, Director, Health Services, Jammu vide communication No. Es-3/4262/5680 dated 10.01.2023, has intimated that Dr. Dimpy Raina was appointed as Dental Surgeon vide Government Order No. 444-HME of 1994 dated 04.07.1994 and has submitted her joining report in the Director, Health Services, Jammu on 02.09.1994;

AND WHEREAS, the said doctor has remained un-authorisedly absent from duty w.e.f 01.07.2010 to 08.09.2013;

AND WHEREAS, vide letter No. HME/HRM/55/2011 part-III dated 24.07.2014, the Administrative Department conveyed the approval to allow Dr. Dimpy Raina, Dental Surgeon to rejoin the Department w.e.f. 09.09.2013 subject to the condition that the period of unauthorized absence shall be decided separately;

AND WHEREAS, Director, Health Services, Jammu, vide communication No.ES-3/4262/3909 dated 16.08.2022, has forwarded the application submitted by Dr. Dimpy Raina, Dental Surgeon, District Hospital Udhampur, wherein, she has requested for settlement of her unauthorized absence period w.e.f. 01.07.2010 to 08.09.2013;

AND WHEREAS, the case for settlement of intervening period of absence w.e.f 01.07.2010 to 08.09.2013 was placed before the Departmental Designated Committee in its meeting held on 12.10.2023 under the chairmanship of Director Finance, H&ME Department;

AND WHEREAS, the Committee deliberated upon the case and recommended as under:-

"Neither DHSJ nor the doctor concerned submitted the reasons of unauthorised absence from duties, as such, may treat the period of absence w.e.f. 01.07.2010 to 08.09.2013 as "Dies-Non".

Besides, the employee shall be warned not to leave her place of posting on unauthorized basis in future for which departmental actions shall be initiated against her without any notice".

NOW, THEREFORE, on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the intervening period of absence w.e.f. 01.07.2010 to 08.09.2013 in favour of Dr. Dimpy Raina, Dental Surgeon, District Hospital Udhampur as **'Dies-Non'**.

The Dental Surgeon, is also warned not to leave her place of posting on unauthorized basis, in future, for which, departmental action shall be initiated against her without any further notice.
