In view of the significant decline in covid-19 cases in the Union Territory of Jammu & Kashmir leading to the underutilization of services doctors deployed in the covid Hospitals and in the interest of health and patient care of the peripheral areas and proper utilization of the services of Medical Professionals, it is hereby ordered that all the doctors deployed to the 500 bedded temporary COVID Hospitals, Jammu/Srinagar, vide Government Order No. 410-JK(HME) of 2021 dated 24.05.2021 read with and Government Order No. 704-JK(HME) of 2021 dated 11.11.2021 & Government Order No. 01-JK(HME) of 2022 dated 05.01.2022, are hereby repatriated to their original place of postings with immediate effect for further duties.

Further, the doctors posted as I/c Deputy Medical Superintendents in the 500 bedded temporary COVID Hospitals, Jammu/ Srinagar, vide Government Order No. 401-JK(HME) of 2021 dated 20.05.2021, are also recalled from the COVID Hospitals, Jammu/Srinagar and shall report in the Directorate of Health Services, Jammu/Kashmir for further postings.

Besides, the Principals of Government Medical College, Srinagar/Jammu shall review the requirement of continuance or otherwise of all contractual/outsourced staff, so that further course of action is taken accordingly.
