**The appointment of the above candidates shall be subject to the fulfillment of following conditions:-**

- a. The appointee(s) shall join in the Directorate of Health Services, Kashmir within a period of 21 days from the date of issuance of this order except Dr. Murtaza Ali who shall report in the Health & Medical Education Department, UT of Ladakh. In case of failure of any appointee to join within the stipulated time period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- b. The appointee(s) shall be allowed to join at the respective place of postings as indicated in **Annexure "A"** to this order only on the production of the following certificates in original:-
  1. Date of Birth Certificate.
  2. Academic/Technical Qualification Certificates.
  3. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
  4. Domicile Certificate.
  5. Health Certificate from the Standing Medical Board.
  6. Relevant category certificate(s), (in case of candidates belonging to reserved categories)
  7. Any other documents as required under rules.
- c. The appointment of the above candidate as Consultant Medicine shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of these appointees shall not be drawn and disbursed to them unless the satisfactory reports in this regard are received in their favour.
- d. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. The probation of the appointees and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 dated 17.06.2020 read with J&K Civil Services (Classification, Control and Appeal) Rules 1956.
- f. **The inter-se-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K, Public Service Commission.**
- g. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.






