- c. The salary of these appointees shall not be drawn and disbursed to them unless the satisfactory reports in this regard are received in their favour.

- g. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
