Subject:- Non-submission of Verification Rolls- Right to forego appointment.

WHEREAS, J&K, Public Service Commission vide their No. PSC/DR/Lecturer/Medicine/H&ME/2019 dated 11.09.2021 notified the provisional select list of candidates for appointment to the post of Lecturer in the Department of Medicine in Government Medical College, Jammu/ Srinagar and subsequently vide communication No. PSC / DR / Lecturer / Medicine / H&ME/2019 dated 06.12.2021, among others, recommended Dr. Tauseef Nabi S/O Ghulam Nabi Khushoo R/O 9 School Enclave Rawalpura for his appointment on the post of Lecturer in the Department of Medicine, Government Medical College, Jammu;

AND WHEREAS, Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, which has been issued in continuation of Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021, inter-alia, provides that the candidates whose recommendations is released by the Selection Agency shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate (s) shall forego their right to appointment forthwith;

AND WHEREAS, vide this Department's letter dated 28.10.2021, Dr. Tauseef Nabi was requested to submit his Character and Antecedents rolls (in triplicate) so that same could be forwarded to Criminal Investigation Department for verification of his character and antecedents. This was also followed by a reminder;

AND WHEREAS, Dr. Tauseef Nabi has failed to submit the verification rolls before the appointing authority within the stipulated period of twenty one (21) days from the date of release of recommendation. As such he shall have to forego his right to appointment in light of the provision of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021.

Now, therefore, Dr. Tauseef Nabi S/O Ghulam Nabi Khushoo R/O 9 School Enclave Rawalpora, who was recommended by Jammu & Kashmir, Public Service Commission for appointment to the post of Lecturer in the Department of Medicine in Government Medical College, Jammu, having failed to submit his verification rolls before the appointing authority within a period of twenty one (21) days from the date of release of recommendation, shall henceforth forego his right to such appointment forthwith.
