i. Re-validation / Release of Rs. 1486.40 lakhs (Rupees Fourteen Crore Eighty Six Lakhs and Forty Thousands) only, under the Centrally Sponsored Scheme, "Strengthening of Drug Regulatory System", and its placement at the disposal of State Drug Controller, Drug and Food Control Organization, J&K, for Setting up of Modern Drug Testing Laboratory at Kathua for its utilization during the current financial year 2021-22.

Lakhs and Forty Thousands) only by State Drug Controller, Drug and Food Control Organization, J&K for e-transfer of these funds into Single Nodal Account (SNA) of Drug & Food Control Organization for its utilization during the current financial year 2021-22 as per the revised procedure of CSS funds notified by Ministry of Finance, Government of India on 23-03-2021 read with other SOPs/ guidelines duly circulated by the Finance Department.

- a. The release of funds shall be subject to the following conditions:-
 - The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department.
 - 2. Treasury Officers shall not entertain bill without complete classification under which funds have been authorized by the Finance Department.
 - Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
 - Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance Department.
 - 5. The State Drug Controller, Drug and Food Control Organization, J&K shall send status report about the scheme in terms of physical and financial progress made during the current financial year.
 - 6. The State Drug Controller, Drug and Food Control Organization, J&K shall send the Utilization Certificates (UCs) of the funds as early as possible and positively before 31-03-2022 to Government of India under intimation to this department.

- 7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
- 8. Director Finance, H&ME Department shall vouchsafe the availability of funds on BEAMS Portal and accordingly release the funds to the concerned.
- 9. The State Drug Controller, Drug and Food Control Organization, J&K shall incur expenditure strictly as per the guidelines of the scheme and the conditions laid down in the sanction letter of the concerned Ministry of Government of India .
