

The appointment of the aforesaid candidates shall be subject to the following conditions:-

- A. The appointment of the candidates shall be strictly governed by the conditions laid down in the J&K Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O. 192 dated 17.06.2020.
- B. The appointees shall submit their joining reports physically to the concerned Head of the Department within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
- C. The appointees shall be allowed to join by the concerned Head of Department on production of the following certificates in original:-
 - i. Academic Qualification Certificates.
 - ii. Matriculation/Date of Birth Certificate.
 - iii. Health Certificate issued by the concerned Medical Board.
 - iv. Domicile Certificate issued by the Competent Authority.
 - v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
 - vi. Any other certificates/documents as required under rules/ norms.
- D. The provisions for probation, pay & allowances and fixed tenure of five years on initial engagement of the appointee shall be governed in terms of the J&K Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O. 192 dated 17.06.2020.
- E. The appointees shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-
 - i. If on verification from the concerned issuing authorities, the qualification certificates/ experience certificates/ reserved category certificates are found forged, false or fake, the appointee shall have no claim for appointment.
 - ii. Salary of the appointees shall not be drawn and disbursed unless and until the satisfactory reports/genuineness of the certificates in respect of Condition E(i) are received.
 - iii. the appointees shall abide by all the terms & conditions as laid down in this appointment order.
 - iv. the appointees shall not be eligible for transfer (wherever transferable) for whatsoever reason during the initial five (05) years of service.
 - v. the appointees have no criminal records and also are not facing any criminal proceedings in any Court of Law.

- vi. the appointees shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.
- F. The inter-se-seniority of the appointees shall be drawn in accordance with the merit secured by them in the selection list prepared by the J&K Services Selection Board.
- G. The appointment of the candidates shall be subject to outcome of the writ petition (s), if any, pending before any Competent Court/Tribunal etc.
- H. The cadre/Department allocated by the J&K Services Selection Board/appointing authority shall not be changed under any circumstances by any authority/ Department.
- I. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on and he/she shall also be liable for criminal prosecution.
