Subject:- Settlement of unauthorized/undecided period for undergoing Registrarship in Orthopaedics in respect of Dr. Bilal Ahmad Baba, Medical Officer.


WHEREAS, Dr. Bilal Ahmad Baba, was appointed as Medical Officer in the Health Services Department vide Government Order No. 333-HME of 2018 dated 29.05.2018;

AND WHEREAS, during initial appointment, the aforesaid doctor was undergoing Registrarship in the Department of Orthopaedics at Government Medical College, Srinagar and applied for extension in joining time in the shape of undertaking devised by Administrative Department upto 12/2019 as his tenure of Registrarship was completing on the said date;

AND WHEREAS, thereafter, extension in joining time in respect of the said doctor was extended upto 12/2019 vide Government Order No. 630-HME of 2018 dated 20.11.2018. The doctor was supposed to join in the month of January-2020, which he did not instead reported Directorate of Health Services, Kashmir on 10.02.2020 after being relieved from GMC Srinagar late by two months of extended spell with the result the case was submitted to Administrative Department for instructions/orders with regard to allowing him to join the department or otherwise;

AND WHEREAS, the doctor concerned represented in Directorate of Health Services, Kashmir with an applicant stating therein that he was supposed to join back in January-2020 but Government Medical College authorities did not relieve him on the said date, instead he was relieved on 07.02.2020;

AND WHEREAS, the Health and Medical Education Department vide communication No. HD/Gaz/Gen/11/2018 dated 25.02.2020



forwarded copy of joining report alongwith relieving order issued by the Principal, Government Medical College, Srinagar to Director, Health Services, Kashmir and requested him to submit posting proposal in respect of Dr. Bilal Ahmad Baba keeping in view the actual/urgent need of health care services in that area purely in the interest of health and patient care;

AND WHEREAS, vide Government Order No.547-JK(HME) of 2020 dated 21.07.2020 Dr Bilal Ahmad Baba, Medical Officer was posted at Trauma Hospital, Gund Ganderbal;


AND WHEREAS, the Health and Medical Education Department had already constituted Departmental Committee for examining such cases vide Government Order No. 511-HME of 2018 dated 13.09.2018 read with Government Order No. 726-HME of 2018 dated 21.12.2018 & Government Order No. 479-JK(HME) of 2021 dated 08.07.2021. Later on the Health and Medical Education Department vide Government Order No. 749-JK(HME) of 2021 dated 30.11.2021, re-constituted the Departmental Committee to be headed by Director Finance, H&ME Department for examining the cases of doctors or any officer/official of sub-ordinate office related to unauthorized absence/ overstay on deputation/ study leave or any other case of similar nature;

AND WHEREAS, the case of Dr. Bilal Ahmad Baba, Medical Officer among others was placed before the Departmental Designated Committee for examination, wherein after series of meetings held w.e.f. 13.12.2021 to 15.12.2021 deliberated upon the matter and recommended as under:-

- i. The Committee recommends to grant extension in joining time in favour of Dr. Bilal Ahmad Baba, Medical Officer, upto 20.07.2020 instead of 12/2019 by taking an administrative decision in the matter, the same shall be without any financial implication and subject to the condition that the said doctor was not involved in any subversive activities as well as not employed in any Govt./Private Sector for which an affidavit duly authenticated by the 1st Class judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor. However, such extension period shall not count as service in the Department.

Now therefore, the Department while taking considerate view in the matter as per recommendations of the Committee & in the interest of patient care, accords sanction as under:-

- i. to grant of extension in joining time in favour of Dr. Bilal Ahmad Baba, Medical Officer, upto 20.07.2020 instead of 12/2019, however, the same shall be without any financial implication and subject to the condition that



the said doctor was not involved in any subversive activities as well as not employed in any Govt./Private Sector for which an affidavit duly authenticated by the 1st Class judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor. However, such extension period shall not count as service in the Department.


