Subject:- Non-submission of Verification Rolls- Forfeiture of right to engagement on academic arrangement basis.

Government Order No: 228-JK(HME) of 2022

WHEREAS, On the recommendation of the Selection Committee provided in the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O. 364 of 2020 dated 27.11.2020, the following two candidates were, among others, recommended for engagement on the posts of Causality Medical Officers in Government Medical College, Anantnag:-

S.No	Name of the Candidate with parentage and residential address
1	Dr. Ishfaq Ah Reshi S/O Ab. Salam Reshi R/O Hakura Dooru.
2	Dr. Shiekh-UI-Islam S/O Hamid Ullah Pala R/O Bhan Qaimoh, Kulgam.

AND WHEREAS, Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, inter-alia, provides that the candidates whose recommendations is released by the Selection Agency, shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate (s) shall forego their right to appointment forthwith;

AND WHEREAS, vide this Department's letter dated 10.08.2021, the Principal, Government Medical College, Anantnag was requested to submit The Character and Antecedents rolls (in triplicate) of these two candidates so that the same could be forwarded to the Criminal Investigation Department for verification of their Character and Antecedents;

AND WHEREAS, the Principal GMC, Anantnag informed that the above candidates have failed to submit the verification rolls within the stipulated period of twenty one (21) days from the date of release of recommendation;

AND WHEREAS, the issue has been examined in the Health and Medical Education Department and it has been concluded that since these candidates have failed to submit their verification rolls within the stipulated period of 21 days, as such they shall have to forego their right to engagement in light of the relevant provisions of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021.

Now, therefore, Dr. Ishfaq Ah Reshi S/o Ab. Salam Reshi R/o Hakura Dooru and Dr. Sheikh-UI-Islam S/o Hamid Ullah Pala R/o Bhan Qaimoh, Kulgam, who were recommended by the Selection Committee for engagement on the posts of Causality Medical Officer in Government Medical College, Anantnag, having failed to submit their verification rolls before the competent authority within a period of twenty one (21) days from the date of release of recommendation, shall forego their right to such engagement forthwith.




