▶ The appointment of the above candidates shall be subject to the following terms and conditions:-

1. The above candidates shall report to the Principal, Government Medical College, Anantnag/Government Medical College, Baramulla/ Government Medical College, Rajouri (as the case may be) and in case of failure of these appointees to join within a period of twenty one (21) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
2. They shall be allowed to join only on production of the following documents/certificates in original:-
 - a. Date of Birth Certificate.
 - b. Qualification Certificates.
 - c. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
 - d. Domicile Certificate.
 - e. Health Certificate from the Standing Medical Board.
 - f. Any other documents as required under rules.
3. The appointment of the above candidates as Assistant Professors shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in this regard shall be received in their favour.
4. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009. The probation of the appointees and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 dated 17.06.2020, read with J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
5. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
6. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.


