Sanction is hereby accorded to the deputation of Dr. Mudasar Akram, Medical Officer, CHC Akhnoor and Dr. Basharat Ramzan, Medical Officer, DH Bandipora to Government Medical College, Srinagar for undergoing tenure posting/training course as Registrar in the discipline of Paediatrics at Government Medical, Srinagar for a period of three years on standard terms and conditions of deputation, with immediate effect.

However the deputation in respect of aforesaid doctors shall be subject to the following conditions:-

- i. They have completed period of probation or 3 years of service whichever is later and are intending to undergo such tenure posting/training course for first time during their service.
- ii. They shall retain their lien/promotion prospects in their own parent department.
- iii. They shall have no superior claim over their seniors for consideration of promotion after acquiring such higher qualification(s).
- iv. In case, the concerned doctor(s) fails to rejoin back in their parent department immediately after completion of such tenure posting/training course, disciplinary proceedings shall be initiated against him without any further notice.




