Subject:- Engagement order of faculty positions of Government Unani Medical College, Ganderbal, Kashmir under SO 364 of 2020.

WHEREAS, vide Government Order No. 211-JK(HME) of 2023 dated 10.03.2023, 12 candidates were engaged as Assistant Professors in their respective disciplines, in Government Unani Medical College cum Hospital, Ganderbal, Kashmir;

AND WHEREAS, the selected candidates were directed to report, Principal, Government Unani medical College cum Hospital, Ganderbal Kashmir, for joining within a period of 21(twenty one) days from the date of issuance of the engagement order, failing which his/her engagement shall stand cancelled ab-initio, without any further notice;

AND WHEREAS, one candidate namely Dr. Syed Sabahat Ashraf D/O Peerzada Mohmmad Ashraf was selected against the post of Assistant Professor Ilmu Atfal (Pediatrics) and Assistant Professor Illaj Bit Tadbeer (Regimental Therapy) appearing at S. No. 4 and 06 of the engagement order;

AND WHEREAS, Principal, Government Unanai Medical College cum Hospital Ganderbal, Kashmir, vide his communication No. GUMC/PS/22-23/2958-61 dated 23.03.2023, informed that Dr. Syed Sabahat Ashraf has joined in the college on 13.03.2023, against the post of Assistant Professor Illaj Bit Tadbeer (Regimental Therapy) and has surrendered her claim against the post of Assistant Professor Ilmu Atfal (Pediatrics)

AND WHEREAS, due to non joining of Dr.Sabahat Ashraf against the post of Assistant Professor Ilmu Atfal (Pediatrics), the post became vacant and it was requested by the Principal, Government Unani Medical College cum Hospital, Ganderbal, Kashmir to have the said vacancy been filled up by operating upon the waiting list as per merit, so as to enable the college to obtain the Letter of Permission (LOP) from the National Commission for Indian Medicine, Ministry of AYUSH, Government of India, for starting the 3rd batch in the college;

AND WHEREAS, as per selection list furnished by the Committee, constituted in terms of Rule 6 of the Jammu and Kashmir (Medical Dental Academic Arrangement Basis) Rules, 2020, notified vide SO 364 of 2020 dated 27.11.2020, one candidate namely

Dr.Asraf Ahmad Wani S/O Mohd Yousuf Wani R/O Ratnipora, Pulwama is falling in the waiting list, having secured 62.25 points;

Now therefore, in view of the above, it is hereby ordered that:-

(i) The engagement in favour of Dr. Syed Sabahat Ashraf D/O Peerzada Mohmmad Ashraf, against the post of Assistant Professor Ilmu Atfal (Pediatrics) made vide Government Order No. 211-JK(HME) of 2023 dated 10.03.2023, is hereby cancelled with immediate effect, due to her joining against the post of Assistant Professor Illaj Bit Tadbeer (Regimental Therapy)

(ii) Consequent upon the cancellation of engagement order in favour of Dr.Syed Sabahat Ashraf D/O Peerzada Mohmmad Ashraf, against the post of Assistant Professor Ilmu Atfal (Pediatrics), Dr. Asrar Ahmad Wani S/O Mohd Yousuf Wani R/O Ratnipora, Pulwama is hereby engaged against the post of Assistant Professor Ilmu Atfal(Pediatrics) in terms of SO 364 dated 27.11.2020, however the terms and conditions as envisaged in Government order No. 211-JK(HME) of 2023 dated 10.03.2023, shall remain same.
