

WHEREAS, Dr. Shafiq Hackla, was appointed as Medical Officer in the Health Services, Department vide Government Order No. 333-HME of 2018 dated 29-05-2018;

AND WHEREAS, at the time of his appointment, the said doctor was undergoing M.S. Orthopaedics in Government Medical College, Jammu and had applied for extension in joining time upto completion of his course;

AND WHEREAS, the Health & Medical Education Department vide Government Order No. 630-HME of 2018 dated 20.11.2018, among others, accorded sanction to the extension of joining time in respect of Dr. Shafiq Hackla, Medical Officer figuring at (S.No.229 ) upto 09/2020;

AND WHEREAS, the case was examined in the department and it has been decided that as per the Government Order No. 630-HME of 2018 dated 20-11-2018, the period of extension in favour of Dr. Shafiq Hackla was extended upto 09/2020 and his appointment as per the extension order shall remain protected for the period of extension i.e. 09/2020 and the said doctor was required to submit his joining report within the period of extension. However, the said doctor has failed to submit his joining report with in the stipulated time period and submit his joining report in the Directorate of Health Services, Jammu on 19-03-2021 i.e. after the expiry of the period of extension in the joining time. As such his appointment needs to be cancelled abi-inito in view of the fact that he has failed to join the Government Services during the period of extension in the joining time

granted upto 09/2020 and his services are no more protected after the expiry of extended period;

Now, therefore, it is hereby ordered that the appointment in respect of Dr. Shafiq Hackla, Medical Officer ordered vide Government Order No. No. 333-HME of 2018 dated 29-05-2018 read with Government Order No. 630-HME of 2018 dated 20-11-2018 is cancelled ab-initio for his failure to join the department within the period of extension in the joining time granted upto 09/2020 vide aforesaid Government Order.
