 - d. Health Certificate from the Standing Medical Board.
 - e. Any other documents as required under rules.
3. The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in this regard are received in his favour.
4. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
5. The appointee shall be on probation for a period of two (02) years.
