Subject: Settlement of unauthorized absence/undecided period/acceptance of rejoining in respect of Dr. Javaid Hassan War, Medical Officer.

**Government Order No. 372 -JK(HME) of 2022**  
**Dated: 03 .06.2022**

WHEREAS, Dr. Javaid Hassan War, was appointed as Medical Officer in the Health Services Department vide Government Order No. 938-JK (HME) of 2020 dated:31/12/2020 and was posted at Block Chadoora;

AND WHEREAS, the aforesaid doctor while posted at Block Chadoora remained un-authorizedly absent with effect from 15/02/2021;

AND WHEREAS, while the case of the doctor was being initiated for disciplinary proceedings by Directorate of Health Services, Kashmir, the said doctor approached with an representation requesting to accept his joining which stands communicated by CMO, Budgam vide his communication No. CMOB/Est/-11/4973-74 dated 29.12.2021;

AND WHEREAS, Directorate of Health Services, Kashmir has forwarded the case of the doctor regarding settlement of period of authorized/unauthorized absence/acceptance of rejoining to the Administrative Department;

AND WHEREAS, The Health and Medical Education Department had already constituted Departmental Committee for examining such cases vide Government Order No. 511-HME of 2018 dated 13.09.2018 read with Government Order No. 726-HME of 2018 dated 21.12.2018 & Government Order No. 479-JK(HME) of 2021 dated 08.07.2021. Later on the Health and Medical Education Department vide Government Order No. 749-JK(HME) of 2021 dated 30.11.2021, re-constituted the Departmental Committee to be headed by Director Finance, H&ME Department for examining the cases of doctors or any officer/official of sub-ordinate office related to unauthorized absence/ overstay on deputation/ study leave or any other case of similar nature;

AND WHEREAS, accordingly, the case was placed before the Departmental Designated Committee, who in its series of meetings held

on 10.01.2022 & 04.04.2022 deliberated upon the matter and recommended as under:-

"The Committee recommends to allow Dr. Javaid Hassan War Medical Officer to re-join prospectively subject to condition that his period of probation shall start afresh and he shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice."

Now therefore, the Department while taking considerate view in the matter as per recommendations of the Committee & in the interest of patient care, accords sanction as under:

"to allow Dr. Javaid Hassan War Medical Officer to re-join prospectively subject to condition that his period of probation shall start afresh and he is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".
