

Unani Medical College Cum Hospital, Ganderbal Kashmir vide communication No. GUMC/PS/22/432-34 dated 28.04.2022 communicated that out of the above three, only one candidate namely, Dr. Raheela Javid D/O Javid Shabnum R/O 09 Bilal Colony, Zakura, Srinagar, joined in the Institution which makes it clear that the other two engaged candidates, appearing at S.
