**WHEREAS,** on the recommendations of J&K Public Service Commission conveyed vide letter No. PSC/DR/Lect/Forensic Med/H&ME/2019 dated 27.10.2021, among others, **Dr. Uzma Manzoor Bachh D/O Manzoor Ahmad Bachh R/O Kursu Rajbagh Srinagar,** was appointed as Assistant Professor in the Department of Forensic Medicine in Government Medical College, Anantnag vide Government Order No. 209-JK(HME) of 2022 dated 20.04.2022;

**AND WHEREAS,** the above Government Order provided that the candidate shall join within a period of 21 days, failing which the appointment shall be deemed to have been cancelled without any further notice;

**AND WHEREAS,** the Principal, Government Medical College, Anantnag has reported that the above candidate has not joined the Department of Forensic Medicine, Government Medical College, Anantnag within the stipulated time of twenty one (21) days and has requested for operation of wait list;

**AND WHEREAS,** the case has been examined in the Health & Medical Education Department and it has been decided to cancel the appointment of Dr. Uzma Manzoor Bachh as Assistant Professor, Forensic Medicine in Government Medical College, Anantnag.

**Now, therefore,** the appointment of **Dr. Uzma Manzoor Bachh D/O Manzoor Ahmad Bachh R/O Kursu Rajbagh Srinagar,** as Assistant Professor in the Department of Forensic Medicine in Government Medical College, Anantnag is hereby cancelled *ab-initio*.


