 - 4. Domicile Certificate.
 - 5. Health Certificate from the Standing Medical Board.
 - 6. Relevant category certificate(s), (in case of candidates belonging to reserved categories)
 - 7. Any other documents as required under rules.

c. The appointment of the above candidate as Consultant Medicine shall further be subject to the verification/genuineness of the qualification certificates from the

concerned issuing authorities. The salary of these appointee shall not be drawn and disbursed to him unless the satisfactory reports in this regard are received in his favour.

- d. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. The probation of the appointee and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 dated 17.06.2020 read with J&K Civil Services (Classification, Control and Appeal) Rules 1956.
- f. The inter-se-seniority of the above appointee shall be as per the merit secured by him in the selection process as indicated against each in the select list furnished by the J&K, Public Service Commission.
- g. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- h. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
