The above candidates shall report to the Principal, Government Medical College, Rajouri for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which their engagement, as such shall stand cancelled without any further notice.

The arrangement shall be purely on temporary basis and shall not confer upon the candidates any special claim/ right for their appointment against the said posts on regular basis as and when the same are filled under rules.

The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one (01) year or till the posts are filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.

The above engagements shall be regulated under other terms and conditions as specified in S.O-364 dated 27.11.2020. The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections are made in accordance with the rules of recruitment governing the post, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
