Ex-post facto sanction, in relaxation of rule 6-A of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, is hereby accorded to the reimbursement of the medical expenses incurred by Dr. Nitika Gupta, Assistant Professor, GMC, Kathua on her own treatment at Ganga Medical Centre & Hospitals Pvt. Ltd, Coimbatore, subject to the following conditions:-

- Reimbursement of charges shall be restricted to items / procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items / procedures in AIIMS, New Delhi.
- All relevant medical bills / vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- Essentiality Certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- Certificate from Competent Medical Authority (Director Health Services / Principal GMC / Other) is obtained to establish the genuineness of the treatment availed in the said hospital.


