**Subject: Representation of Dr. Sameer Abrol for re-joining – acceptance thereof.**

**Government Order No. 503 -JK(HME) of 2022**  
**Dated: 14 .07.2022**

**WHEREAS,** Dr. Sameer Abrol was appointed as Medical Officer vide Government Order No. 132-HME of 2014 dated 04.03.2014;


**AND WHEREAS,** after completion of Registrarship, the said doctor reported in the Directorate of Health Services Jammu on 31.03.2018 and proceeded for DNB Gastroenterology without prior permission from the competent authority;

**AND WHEREAS,** Director Health Services, Jammu vide No. ES-3/6095/5496- 97 dated 19.03.2020, issued a notice to the said doctor to join back his duties otherwise action as warranted under rules shall be initiated against him and in response, Dr. Sameer Abrol has stated that he has been selected for DNB Gastroenterology in Fortis Escorts Hospital, Jaipur, Rajasthan and has completed two years of DNB and only seven months are now left for appearing in final examination, following which he would be joining back at the earliest;

**AND WHEREAS,** Director Health Services, Jammu vide No. ES-3/6095/856 dated 31.05.2021, has forwarded the joining report of the said doctor for information and necessary instruction in the matter;

**AND WHEREAS,** vide No. HD-Gaz0Gen/96/2021-02 dated 17.06.2022, a notice was issued to Dr. Sameer Abrol to explain his position and to submit a written statement as to why the disciplinary proceedings as provided in rules shall not be initiated against him;

**AND WHEREAS,** in response to final notice, Dr. Sameer Abrol has intimated that he was selected for Super Speciality course in Gastroenterology (DNB Gastro) by National Board of Examination and only seven days were given for joining otherwise he missed that opportunity, as such, he joined the said course at Fortis, Jaipur and after completion of the course, said doctor submitted his joining in the Directorate on 19.01.2021 and requested to allow him to join back his duties and to consider his case sympathetically;

**AND WHEREAS,** the case of Dr. Sameer Abrol, Medical Officer was examined in the Department and in view of his Superspecialization and willingness to serve the Union Territory of Jammu and Kashmir, it has been decided to allow Dr. Sameer Abrol, Medical Officer to resume duties;

**NOW, THEREFORE,** sanction is hereby accorded to accept the joining report of Dr. Sameer Abrol, Medical Officer (DNB Gastroenterology) and allow him to resume his duties, subject to the following conditions:-

- a. That the said doctor was not involved in any subversive activities as well as was not employed in any other Government/Private Sector during the period of absence for which an affidavit duly authenticated by the 1<sup>st</sup> class Judicial Magistrate be obtained by the Directorate of Health Services, Jammu.
- b. The concerned doctor is warned not to leave his place of posting for any occasion whatsoever in future without proper permission from the competent authority, failing which, disciplinary action in terms of Jammu & Kashmir Civil Services Regulations Volume-I shall be initiated against him without giving any further chance or notice.
- c. The period of unauthorized absence of the doctor shall be decided separately;
