
Government Order No. 523 - JK(HME) of 2022 D a t e d : 20 - 07 - 2022

As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Anuradha D/O Punjab Singh R/O Kamal Nagar, Keran Road Bantalab, Jammu** as Lecturer in the Department of Nephrology, Super Specialty Hospital, Government Medical College, Jammu, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 dated 27.11.2020.

The engagee shall report to the Principal, Government Medical College, Jammu for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which her engagement as such shall stand cancelled without any further notice.

The above arrangement shall be purely on temporary basis and shall not confer upon the engagee any special claim/ right for her appointment against the said post on regular basis as and when the same is filled under rules.

The engagee shall have to execute an agreement with the Government on the prescribed form in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangment Basis) Rules, 2020, notified vide S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year or till the post is filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.



The above engagement shall be regulated under other terms and conditions as specified in S.O-364 dated 27.11.2020. The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections are made in accordance with the rules of recruitment governing the post, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances
