As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Dr. Azia Manzoor Bhat S/O Manzoor Ahmad Bhat R/O Qazi Mohalla Push Mohalla Anantnag**, under OM Category, as Assistant Professor in the Department of Forensic Medicine in Government Medical College, Anantnag, in Pay Level-11 (67700-208700), with immediate effect, subject to the following terms and conditions:

- 1) The above candidate shall report to the Principal, Government Medical College, Anantnag. In case of failure of the appointee to join within a period of twenty one (21) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
- 2) The appointee shall be allowed to join only on production of the following documents/certificates in original:-
  - a) Date of Birth Certificate.
  - b) Qualification Certificates.
  - c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
  - d) Domicile Certificate.
  - e) Health Certificate from the Standing Medical Board.
  - f) Any other documents as required under rules.
- 3) The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities.

- 4) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in this regard are received in his favour.
- 5) The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- 6) The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- 7) The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
