AND WHEREAS, Dr. Sunita Kumari, Medical Officer has now forwarded her case through Directorate of Health Services, Jammu for acceptance of technical resignation in her favour w.e.f. 10th September, 2022;

AND WHEREAS, Article-201 of J&K CSR. Vol-1, envisages as under:-

".....201. Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government Service, provided the consent of the former departmental superior is obtained to accepting, such employment.

Now, therefore, in terms of Article-201 of J&K CSR. Vol-1, the technical resignation tendered by Dr. Sunita Kumari, Medical Officer from J&K Health & Family Welfare (Gazetted) Service is hereby accepted w.e.f. 10th September, 2022, on her own request and her lien in the J&K Health & Family Welfare (Gazetted) Service shall be deemed to have been terminated.
