**Subject: Rejoining of Dr. Burhan Ashiq, Medical Officer.**

**Government Order No. 688 - JK(HME) of 2022**  
**Dated: 26 -09.2022**

**WHEREAS**, Dr. Burhan Ashiq was appointed as Medical Officer vide Govt. Order No. 152-JK(HME) of 2021 dated 02.03.2021 and posted at NTPHC Ind, Block Gool, District Ramban;

**AND WHEREAS**, after joining at NTPHC Ind, Block Gool, District Ramban, the said doctor resorted to unauthorized absent from duties;

**AND WHEREAS**, Dr. Burhan Ashiq, Medical Officer has represented before the Administrative Department on 12.05.2021 for allowing him to join back his duties owing to the reason that he was ill during the period of absent;

**AND WHEREAS**, vide this department's letter No. HD/Gaz/16/2021-02 dated 19.05.2021, the representation of Dr. Burhan Ashiq was forwarded to Director Health Services, Jammu for furnishing a detailed report/recommendations in the matter;

**AND WHEREAS**, Director Health Services, Jammu vide No. DHSJ/ES-3/6766/863 dated 19.05.2022 has forwarded the undertaking of Dr. Burhan Ashiq (MD Anesthesia) Medical Officer duly attested by City Munsif Judicial Magistrate Ist Class Kashmir wherein he has sworn that during the period of absence he has not worked in any Government/private office in any capacity and there is no departmental enquiry pending against him;

**AND WHEREAS**, Director Health Services, Jammu has recommended to consider the request of the doctor favourably for joining back in the department in view of shortage of doctors in District Ramban, as reported by the concerned BMO and Chief Medical Officer, Ramban vide letter No. CMO/RBN/378 dated 21.04.2022;

**AND WHEREAS**, the case of Dr. Burhan Ashiq, Medical Officer was examined in the Department and in view of his health grounds and willingness to serve the department, it has been decided to allow Dr. Burhan Ashiq, Medical Officer (MD Anesthesia) to resume the duties;

**NOW, THEREFORE**, sanction is hereby accorded to accept the joining report of Dr. Burhan Ashiq, Medical Officer (MD Anesthesia) prospectively and allow him to resume his duties with immediate effect, subject to the following conditions:-

  


- a. The concerned doctor is warned not to leave his place of posting for any occasion, whatsoever in future, without proper permission from the Competent Authority, failing which, disciplinary action in terms of Jammu & Kashmir Civil Service Regulations, Volume-I, shall be initiated against him without giving any further chance or notice.
- b. The period of unauthorized absence of the doctor shall be treated as "dies-non"
