The engagement shall be extendable up to maximum of six years (one year at a time and subject to good performance and conduct) or till selections are made in accordance with the rules of recruitment governing the respective post, whichever is earlier, and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.


