1. The above candidate shall report to Principal, Government Medical College, Srinagar. In case of failure of the appointee to join within a period of 21 (twenty one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on production of the following documents/certificates in original:-
  - a) Date of Birth Certificate.
  - b) Qualification Certificates.
  - c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
  - d) Domicile Certificate
  - e) Health Certificate from the Standing Medical Board.
  - f) Reserved Category Certificates.
  - g) Any other documents as required under rules.
3. The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates/Reserved Category Certificate from the concerned issuing authorities. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in this regard are received in his favour.




