The appointees shall be allowed to join only on production of the following documents/certificates in original:-

- Certificates from the concerned District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self-employment scheme has been taken by the appointee.
- Domicile Certificate.
- Health Certificate from the Standing Medical Board.
- Reserved Category Certificate (where-ever applicable).
- Any other documents as required under rules.

Their appointment as Lecturer shall further be subject to the verification/genuineness of the qualification certificates / Reserved Category Certificate (wherever applicable) from the concerned issuing authorities

Their salary shall not be drawn and disbursed to them unless satisfactory reports in this respect are received in their favour.

Their appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

Their inter-se seniority shall be determined in accordance with the merit secured by them in the selection list prepared by the J&K Public Service Commission.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.

Their appointment shall be subject to outcome of the writ petition(s), if any, pending before any court of competent jurisdiction.
