The engagement of the aforementioned candidates shall be subject to following terms and conditions:-

1. They shall report to Principal, Government Medical College, Doda for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice.

2. The engagement shall be purely on temporary basis and shall not confer upon them any special claim/right for their appointment against the said post (s) on regular basis as and when the same are filled-up under rules.

3. They shall have to execute an agreement with the Government on the prescribed Form in terms of SO 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year or till the posts are filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.

4. The above engagements shall be regulated under other terms and conditions as specified in SO 364 of 2020 dated 27.11.2020. The engagements so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections are made in accordance with the rules of recruitment governing the post (s), whichever is earlier, and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.

5. Their salary shall not be drawn and disbursed to them unless satisfactory reports are received in their favour from Criminal Investigation Department to whom a reference shall be made by the Principal, Government Medical College, Doda.


