In terms of Rule 61, Rule 62(a) & Rule 73(1) of the J&K Civil Services (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012, SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Nasreen Akhter, Medical Officer, PHC Daghore for a period of one year (out of three years) w.e.f 02.12.2022 for undergoing MD in Pharmacology at Government Medical College, Jammu, subject to the following conditions:-

- i. The doctor shall have no superior claim over her seniors for consideration for promotion after acquiring higher qualification.
- ii. The stipend, scholarship etc., if any, received during study leave shall be adjusted in her leave salary;
- iii. The doctor shall execute a bond in Form 6 before the Director, Health Services, Jammu, as required under the J&K Civil Services (Leave) Rules, 1979;
- iv. The doctor shall submit the certificate of examination of 1<sup>st</sup> year passed before the Administrative Department before seeking extension in study leave; and
- v. The doctor shall comply with all other conditions as laid down in study leave rules as amended from time to time.
