Subject: Release and advance drawl of UT Share for Centrally Sponsored Scheme "National Ayush Mission" under Capex Budget 2022-23 during the year 2022-23

Government Order No: 162 -JK(HME) of 2023

Dated: 21 -02-2023

In continuation to Govt. Order No. 87-JK(HME) of 2023 dated 31-01-2013, sanction is hereby accorded to the release and advance drawl of funds to the tune of ₹ 92.75 Lakhs (Rupees Ninety Two Lakhs Seventy Five Thousands) only under Capex Budget 2022-23 as matching UT Share under Centrally Sponsored Scheme "National Ayush Mission" and its placement at the disposal of Director Ayush, J&K for utilization of the funds during the current financial year (2022-23) towards the approved components of the scheme.

The sanction to the release and advance drawl of funds shall be subject to the following conditions:-

1. Director Ayush, J&K shall furnish the physical and financial progress report every month to this Department, which shall be open to, on spot verification.
2. The expenditure shall be made strictly, according to the classification under which funds have been authorized by the Finance Department.
3. Treasury Officers shall not entertain bills without ascertaining complete classification under which funds have been authorized by the Finance Department.
4. Drawing and Disbursing Officer (DDO) shall complete all the codal formalities before presentation of bills at the Treasury.
5. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
6. The funds so released shall be utilized for the purpose meant for without any diversion at all.
7. All the required codal formalities shall be observed at all levels with due diligence.
8. The Red D.C account shall be furnished to the concerned quarters within the stipulated time.
9. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release the funds to the concerned.

 11. All conditions contained in BEAMS release order shall be adhered to.
