## Government Order No. 233.-JK(HME) of 2022 Dated: 25.04.2022

In terms of Article 230 (i) of the Jammu and Kashmir Civil Service Regulations Volume-I read with SRO-217 dated 22.05.2017, issued by the Finance Department, sanction is hereby accorded to the voluntary retirement of Smt. Dilshada Akhter, Female, MPHW, Block Nagam, District Budgam, from sub-ordinate services of the Directorate General, Family Welfare, MCH & Immunization, J&K, w.e.f. 31.10.2021, subject to the following conditions:-

- 1. That she has not drawn any salary from Government exchequer w.e.f. 01.11.2021 onwards.
- 2. That there is no departmental/judicial enquiry pending against the official.
- 3. That the official has permanent status/five years of quasi-permanent status or is confirmed on any post.
- 4. That total service w.e.f. 22.04.1993 to 31.10.2021 i.e., the date of seeking voluntary retirement is qualifying except period spent on leave without pay/diesnon.
- 5. That service is verified with reference to Pay A.C. Roll w.e.f. 22.04.1993 to 31.10.2021.
- 6. That sanction to voluntary retirement from Competent Authority is invariable furnished with the pension case.
- 7. That the Head of the office shall ensure that the fixation pay recorded in the service book has been verified by him/her in accordance with Finance Department's Circular No. A/60 (78) -194 dated 14.02.2005. Rules 17.4 of J&K Financial Code Vol (I) may also be referred to.
- 8. That the official viz. Smt. Dilshada Akhter, Female MPHW, is not retained in Government Services beyond intended date of voluntary retirement i.e., 31.10.2021.
