

The sanction shall be subject to the following conditions:

1. The allotment of Treasury shall be made separately by DGAT, J&K.
2. That the DDO Code shall be allotted by Accountant General, J&K in favor of the DDO(s) concerned.
3. That the funds allotted under relevant Head of Account and placed at the disposal of DDO concerned shall be utilized in accordance with the laid down rules as contained in GFRs-2017 and other required formalities issued by Government from time to time.
