Subject: Cancellation of appointment - revocation thereof.

WHEREAS, on the basis of recommendations of the J&K Public Service Commission, the Health and Medical Education Department vide Government Order No. 748-JK(HME) of 2022 dated 25.10.2022, accorded sanction to the temporary appointment of two hundred forty one (241) candidates (in respect of whom verification reports were received from J&K Criminal Investigation Department) as Medical Officers in the Jammu and Kashmir Health and Family Welfare (Gazetted) Service in the pay scale Level-9 (Rs52700-166700), alongwith their postings subject to the fulfillment of various conditions;

AND WHEREAS, one of the condition envisaged in the aforesaid Government Order was that the appointee(s) shall submit their joining reports physically to their concerned drawing and disbursing Officers (DDOs) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice;

AND WHEREAS, based on the aforesaid condition, the Health and Medical Education Department vide communication No. HD/Gaz0Gen/47/2021-02 dated 15.11.2022 requested Director, Health Services, Kashmir/Jammu to furnish the details of all such Medical Officers (Appointees) who have physically joined/not-joined as per prescribed proforma(s) duly authenticated by the concerned DDOs in a consolidated statements;

AND WHEREAS, the Director, Health Services, Kashmir vide communication No. Est/3/1-133/14442 dated 22-11-2022 and Director Health Services, Jammu vide communication No. DHS/Es-3/PSC/202/5150

dated 24-11-2022 furnished the information/particulars of 100 Medical Officers (42 from Kashmir Province and 51 from Jammu Province) who failed to join at their respective place of posting till the last date of joining i.e. 14-11-2022. Besides, 6 Medical Officers (03 each from both the Divisions) and 01 Medical Officer was reported to have absconded after submitting his joining report at his place of posting;

AND WHEREAS, on the basis of the aforesaid information, the Health and Medical Education Department vide Government Order No. 930-JK(HME) of 2022 dated 21-12-2022, ordered that the appointments in respect of 93 Medical Officers, appointed vide Government Order No. 748-JK(HME) of 2022 dated 25-10-2022, shall be deemed to have been cancelled ab-initio for their failure to join within prescribed period of joining time which also included the names of Dr. Mir Hamid Bashir figuring at S. No. 40 in Annexure -A of the aforesaid Government Order;

AND WHEREAS, after issuance of cancellation of appointment, Dr. Mir Hamid Bashir, S/o Bashir Ahmad Mir R/o 75 Pethbugh Anantnag, District Anantnag, appointed as Medical Officer under OM category, and posted at PHC Awoora represented that his appointment has been wrongly cancelled as he has joined in the office of BMO Sallar on 29.10.2022 and concerned BMO vide Order No. BMO/EST/1027-30 dated 29.10.2022 directed him to report at PHC, Awoora. Since then, he is performing his duties as per the roster issued by the concerned in-charge Medical Officer of PHC Awoora, Anantnag and submitted documentary in support to his plea;

AND WHEREAS, the Health and Medical Education Department vide communication No. HD-Gaz0Gen/964/2022-02 dated 28.12.2022 sought factual report from Director, Health Services, Kashmir;

AND WHEREAS, the Director, Health Services, Kashmir vide communication No. Est-3/1-133/30 dated 03-01-2023 intimated that an inadvertent mistake has been made by the Chief Medical Officer, Kupwara while furnishing the information by mentioning the name of doctor concerned in the list of doctors who failed to join Physically. The location of Awoora is located both in Anantnag and Kupwara districts and accordingly CMO, Kupwara reported the appointee among those failing to join within the stipulated time whileas the appointee had already joined the place of posting in Anantnag district. Accordingly, the Director, Health Services, Kashmir has recommended for revocation of cancellation of appointment in respect of Dr. Mir Hamid Bashir as he is physically performing his duties at his place of posting viz PHC Awoora, Anantnag.

NOW, THEREFORE, it is, hereby, ordered that the details/particulars of the following Medical Officer shall and shall always be deemed to have been deleted from the purview of Government Order No. 930-JK(HME) of 2022 dated 21-12-2022 (Annexure-A) by virtue of which, among others, appointment of Dr. Mir Hamid Bashir, Medical Officer was also cancelled without his fault:-
