On the basis of recommendations of the J&K Service Selection Board duly forwarded by the General Administration Department vide OM dated 19.10.2021 and in continuation of Government Order No. 455-JK(HME) of 2022 dated 27.06.2022 on the subject, sanction is hereby accorded to the temporary appointment of the following (02 candidates in respect of whom CID reports have been received from the concerned Deputy Commissioner), as Class-IV in the Pay Level SL-I (14800-47100) in the organization of the Health & Medical Education Department, as per the details indicated against each:-



The appointment of the aforesaid candidates shall be subject to the following conditions:-

A. The appointees shall submit their joining reports physically to the concerned HODs of the Organizations indicated against each within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

B. The appointees shall be allowed to join by the concerned Head of Departments(HODs) only on production of the following certificates in original:-

- Academic Qualification Certificates.
- Matriculation/Date of Birth Certificate.
- Health Certificate issued by the Chief Medical Officer.
- Domicile Certificate issued by the Competent Authority.
- Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
- Relevant category certificate(s), (in case of candidates belonging to reserved categories).



vii. Any other certificates/documents as required under rules/norms.

C. The appointees shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-

- i. if on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.
- ii. salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report/ genuineness of the certificates in respect of Condition C (i) is received.
- iii. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- iv. appointee shall abide by all the terms & conditions as laid down in this appointment order.
- v. The appointee shall be on probation for a period of two (02) years.
- vi. appointee have no criminal records and also is not facing any criminal proceedings in any Court of Law.
- vii. appointee shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.

D. The inter-se-seniority of the appointees shall be drawn in accordance with the merit secured by these appointees in the selection list prepared by the J&K Services Selection Board.

E. The appointment of the candidates shall be subject to outcome of the writ petition (s), if any, pending before any Competent Court/Tribunal etc.

F. The cadres/Departments allocated by the J&K Services Selection Board/ appointing authority shall not be changed under any circumstances by any authority/Department.

G. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on and he/she shall also be liable for criminal prosecution.
