Ex-post facto sanction is hereby accorded to the reimbursement of the medical expenses incurred by Sh. Muzaffar Ali Khan, Pharmacist / Storekeeper on his self treatment at Fortis Hospital, Mohali, Punjab, in relaxation of Rule 6 (1) and 6-A of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, subject to the following conditions:

- a) Reimbursement of charges shall be restricted to items / procedures admissible under rules for the period of hospitalization and cost thereof is restricted to the extent of rates as applicable to such items / procedures at PGI, Chandigarh.
- b) All relevant medical bills / vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- c) Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- d) Certificate from Competent Medical Authority (Director Health Services / Principal GMC / Other) is obtained to establish the genuineness of the treatment availed in the said hospital.
