As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Dr. Imran Hussain Bhat S/O Gh Mustafa Bhat R/O H/O GH Mustafa Bhat Hardukathal Sofipora Sallar**, against the post of Lecturer in the discipline of Anesthesiology, under OM Category, in Government Medical College, Srinagar in the pay level-9 (52700-166700), notionally w.e.f 16.09.2022, subject to the following terms and conditions:

1. The above candidate shall report to the Principal, Government Medical College, Srinagar. In case of failure of the appointee to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on production of the following documents/certificates in original:-
  - a) Date of Birth Certificate.
  - b) Qualification Certificates.
  - c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self-employment scheme has been taken by the appointee.
  - d) Domicile Certificate.
  - e) Health Certificate from the Standing Medical Board.
  - f) Any other documents as required under rules.
3. The appointment as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities.
4. The salary shall not be drawn and disbursed to him unless satisfactory reports in this respect are received in his favour.
5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

6. The inter-se seniority shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Public Service Commission.
7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
