The appointment of afore-mentioned candidates shall be subject to the following terms and conditions:-

**1.** The above candidates shall report to the Principal, Government Medical College, Jammu. In case of failure of the appointees to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

**2.** The appointees shall be allowed to join only on production of the following documents/certificates in original:-

- a. Date of Birth Certificate.
- b. Qualification Certificates.
- c. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self-employment scheme has been taken by the appointee.
- d. Domicile Certificate.
- e. Health Certificate from the Standing Medical Board.
- g. Any other documents as required under rules.

3. The appointment of the above candidates as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointees shall not be drawn and disbursed to them unless satisfactory reports in this regard are received in their favour.

4. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 Dated: 24.12.2009.

5. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.

6. The inter-se seniority of the appointees shall be determined in accordance with the merit of the J&K Public Service Commission.

7. The appointment of above candidates shall be subject to outcome of the writ petition(s), if any, pending before any competent Court of Law.
