In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Vijay Bharti Dhingra, Medical Officer, SDH Jagti for undergoing DNB Course in Psychiatry from Government Medical College, Jammu (Psychiatry Hospital) for a period of one year (out of three years) w.e.f 02.03.2022 in the first instance, subject to the following conditions:-

- i. The work load on account of his study leave is managed through internal arrangement;
- ii. That the doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.

Besides, the period during which the said doctor was pursuing PG in Pathology at Government Medical College, Jammu shall be treated as leave whatever kind due.


