Senior Residents/Registrars etc. beyond prescribed period of three years in gross violation of policy/guidelines of the department shall be deemed to have been relieved with immediate effect from the Government Medical College, Anantnag and are directed to report in the Directorate of Health Services, Kashmir for further duties:-
