

As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Dr. Shabir Ahmad Mir S/o Gh. Mohd Mir R/o Wagar Kremshore Khan Sahib, Budgam as Consultant Surgery** in the Health & Family Welfare Department, in Pay Level-11 (Rs. 67700-208700), under **open merit category** and is **deputed to Government Medical College, Srinagar for utilizing his services in the Renal Transplant Programme** on standard terms and conditions of deputation with immediate effect, purely in the interest of health & patient care.

**The appointment of the above candidates shall be subject to the fulfillment of following conditions:-**

- a. The appointee shall report in the Directorate of Health Services, Kashmir within a period of 21 days from the date of issuance of this order. In case of failure of appointee to join within the aforesaid time period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
- b. The appointee shall be allowed to join only on the production of the following documents/certificates in original:-
  1. Date of Birth Certificate.
  2. Academic/Technical Qualification Certificates.
  3. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
  4. Domicile Certificate.
  5. Health Certificate from the Standing Medical Board.
  6. Relevant category certificate(s), (in case of candidates belonging to reserved categories)
  7. Any other documents as required under rules.





- c. The appointment of the above candidate as Consultant Surgery shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities.
- d. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (c) above is received in his favour.
- e. The appointee shall be on probation for a period of two years.
- f. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- g. **The inter-se-seniority of the above appointee shall be as per the merit secured by him in the selection process as indicated against him in the select list furnished by the J&K, Public Service Commission.**
- h. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- i. The appointment shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.


