As recommended by J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Dr. Shamim Ahmad Bhat S/O Wali Mohammad Bhat R/O 96 Kachi-Pora Rajpora**, under **OM Category** as Lecturer in the Department of Orthopedics in Government Medical College, Srinagar in the Pay Level-9 (52700-166700), notionally w.e.f. 03.10.2022, subject to following terms and conditions:-

1. The above candidate shall report to Principal, Government Medical College, Srinagar. In case of failure of the appointee to join within a period of twenty one (21) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on production of following documents/certificates in original:-

- a) Date of Birth Certificate.
- b) Qualification Certificates.
- c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- d) Domicile Certificate
- e) Health Certificate from the Standing Medical Board.
- f) Any other documents as required under rules.

3. The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned

issuing authorities. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory reports in this regard are received in his favour.

4. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

5. The appointee shall be on probation for a period of two years.

6. The inter-se seniority of the candidate shall be determined in accordance with the merit of the J&K PSC.

7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.

8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
