In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Hina Ishaq, Medical Officer, PHC Nowgam, Srinagar for undergoing DNB-Psychiatry at Government Medical College, Jammu for a period of one year w.e.f. 17.11.2022 (out of three years) in the first instance. However, this shall be subject to the following conditions:-

- i. That the work load on account of her study leave is managed through internal arrangement;
- ii. That she shall have no superior claim over her seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in her salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.


