In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Mohammad Yousuf Bhat, Medical Officer, PHC DK Pora, Shopian for undergoing Diploma Paediatrics at Government Medical College, Baramulla for a period of one year w.e.f. 17.11.2022 (out of two years) in the first instance. However, this shall be subject to the following conditions:-

- i. That the work load on account of his study leave is managed through internal arrangement;
- ii. That he shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.


