In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Showkat Ahmad Khan, Medical Officer, SDH Beerwah, Budgam for undergoing Post MBBS DNB in Pediatrics at Government Medical College, Baramulla for a period of one year w.e.f. 17.11.2022 (out of three years) in the first instance.
