2) Advance drawl of Rs. 1708.30 lakhs (Rupees Seventeen Crore Eight Lakhs & Thirty Thousands) only as detailed above, by Director Finance, Health & Medical Education Department for crediting the funds into the Single Nodal Account of PMDP Scheme so that funds be transferred to Director, Health Services, Jammu for its utilization during the current financial year 2022-23.

The revalidation/ release of funds shall be subject to the following conditions:-

1. The expenditure shall be made strictly as according to the classification under which funds have been authorized by the Finance Department.
2. Treasury Officers shall not entertain bill without complete classification under which funds have been authorized by the Finance Department.
3. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
4. Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance Department.
5. The Director, Health Services, Jammu shall send status report about the scheme in terms of physical and financial progress made during the current financial year.
6. The Director, Health Services, Jammu shall send the Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2023 to Govt. of India under intimation to this department.
7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
8. Director Finance, H&ME Department shall vouchsafe the availability of funds on the BEAMS portal as accordingly release/ transfer the same to the concerned HOD.
9. The expenditure under the scheme be incurred from the SNA Account only as PFMS will not accept treasury data on Non-SNA releases with effect from 01/12/2022
10. All conditions as stipulated in BEAMS generated release order shall be adhered to in letter & spirit.
11. The expenditure shall be incurred strictly as per the guideline of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of India.


