**Government Order No. 930 -JK(HME) of 2022**  
**Dated: 21.12.2022**

**WHEREAS**, as per recommendation of the J&K Public Service Commission, the Health and Medical Education Department vide Government Order No. 748-JK(HME) of 2022 dated 25.10.2022, accorded sanction to the temporary appointment of **two hundred forty one (241)** candidates (*in respect of whom* verification reports were received from J&K Criminal Investigation Department) as Medical Officers in the Jammu and Kashmir Health and Family Welfare (Gazetted) Service in the pay scale, Level-9 (Rs. 52700-166700), alongwith their postings subject to the fulfillment of various conditions including following condition:-

- A) The appointee(s) shall submit their joining reports physically to their concerned Drawing and Disbursing Officers (DDOs) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

**AND WHEREAS**, in the aforesaid Government order No. 748-JK(HME) of 2022 dated 25.10.2022, it was further ordered that:-



"All the concerned Drawing & Disbursing Officers of Health & Family Welfare Department shall submit categoric report/details of appointees who fail to join physically within the stipulated time period immediately after expiry of 21 days to the Administrative Department by the concerned Directorates. Besides, attendance alongwith documentary evidence in respect of the appointees, who joined physically, shall be submitted at the end of every month to the Administrative Department by the concerned Directorates and in case any discrepancy of facts is brought to the notice of Administrative Department, action as warranted under rules, shall be taken against such DDO(s)".

**AND WHEREAS,** vide this department's letter No.HD/Gaz0Gen/47/2021-02 dated 15.11.2022, the Director, Health Services, Jammu and Director, Health Services, Kashmir were requested to furnish the details of the incumbents who have failed to join before the respective DDOs upto **14.11.2022** or are absconding from their respective place of postings after submitting their joining report or tendered resignation, enabling this department to cancel their appointment, so that waiting list shall be considered to be operated upon;

**AND WHEREAS,** Director, Health Services, Jammu and Director, Health Services, Kashmir vide their communication No. DHS/ES-3/PSC/2022/5150 dated 24.11.2022 & No. Est/3/1-133/14442 dated 22.11.2022 respectively furnished the information/particulars of 100 Medical Officers (appointees) (51 from Jammu Province & 42 from Kashmir Province), who have failed to join at their respective place of postings upto the last date of joining i.e **14.11.2022**. Besides, 6 Medical Officers (appointees) tendered resignations from the post of Medical Officers (03 each from both the Divisions) and 01 Medical Officer is absconding after submitting his joining report at his place of posting.

Now, therefore, it is hereby ordered that:-

- i. the appointments in respect of **93 Medical Officers** who were appointed vide Government Order No. 748-JK(HME) of 2022 dated 25.10.2022 but failed to join at their respective place of postings upto the last date of joining i.e 14.11.2022 **indicated at Annexure-A (page 1-7)** shall be deemed to have been cancelled ab-initio.

- ii. in exercise of the power conferred under Rule 21(1) of J&K Civil Services (Classification, Control and Appeal) Rules 1956, the probation of following **06** Medical Officers is hereby terminated and they are discharged from the J&K Health


