WHEREAS, on the recommendations of J&K Public Service Commission, among others, **Dr. Rohey Jan D/O Jalal Ud Din Rather R/O 6 Baghi-Buchroo Chadoora** was appointed under OM Category as Lecturer in the Department of Anaesthesiology, Government Medical College, Srinagar vide Government Order No. 429-JK(HME) of 2021 dated 01.06.2021, subject to the fulfillment of all other usual terms and conditions of appointment;

AND WHEREAS, on 30.09.2022, Dr. Rohey Jan submitted her resignation before the Principal, Government Medical College, Srinagar citing reasons of her fresh appointment in the Department of Anesthesiology in GMC Srinagar, as the earlier selection list has been challenged in the Court of Law and there is an apprehension of any order from the Court;

AND WHEREAS, the Principal Government Medical College, Srinagar has forwarded the application of the said Lecturer for acceptance of her resignation;

AND WHEREAS, the matter has been examined in the Health & Medical Education Department and it has been decided to accept the resignation of Dr. Rohey Jan with reference to the rules governing the subject;

Now, therefore, in exercise of the powers conferred under Article 200 of the Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, the resignation of Dr. Rohey Jan from the post of Lecturer, Department of Anesthesiology in Government Medical College, Srinagar appointed vide Government Order No. 429-JK(HME) of 2021 dated 01.06.2021, is accepted on her own request and discharge her from the duties w.e.f 30.09.2022, from Government Medical College, Srinagar.
